## **NOTICE**

Kind Attention: All candidates wish to take admission in the 50% Internal quota seats (Delhi University Quota – DUQ) under Delhi University.

In view of the request of Dean, Faculty of Ayurveda, Unani & Homeopathic Medicine, University of Delhi, M/o Ayush has decided to conduct counseling for admission to 50% Internal quota seats (Delhi University Quota – DUQ) under Delhi University along with 50% All India Quota seats through AACCC-PG portal for the academic year 2022-23.

Further, it is also informed that AACCC, M/o Ayush will include 50% Internal quota seats (DUQ) ONLY during Round-2 of AACCC-PG counseling. The eligibility criteria and Reservation Roster applied DUQ seat matrix of the AU&H institutes is provided by the Delhi University (copy enclosed). For any queries in this regard, candidates are requested to contact University of Delhi.

After the completion of second round, the seats which remain vacant will be reverted to the Delhi University for further counseling at their level because the Conversion Algorithm of Delhi University is not compatible with the AACCC-PG portal which made on the basis of Centrally Approved Conversion Algorithm.

Therefore, after the completion of Round-2 of AACCC-PG Counseling, all the candidates who wish to take admission in the vacant DUQ seats are advised to visit the website of the Faculty of Ayurveda & Unani and Faculty of Homeopathic Medicines, University of Delhi (<u>www.fmsc.ac.in</u>)

Your kind cooperation in the matter shall be highly appreciated.






