	Candidates do not wish to join the allotted institute	If not join, Free Exit available. Can participate in subsequent rounds as per the eligibility fixed for that round by filling fresh choices.
	Candidates wish to resign from the joined R-1 seat.	Can avail of Free exit till the date of announcement of the R-2 final result (excluding final result date) and can participate in subsequent rounds as per the eligibility fixed for that round by filling fresh choices.

		Can avail exit with forfeiture from the date of announcement of R-2 final result till 3 days prior to the commencement of Round 3 so that can participate in subsequent rounds as per the eligibility fixed for that round by paying complete fees again and filling fresh choices.
		R-1 admitted candidates who withdraw their seats with forfeiture between 3 days prior to the commencement of Round 3 and till the date of publication of the 3 rd Round final result (excluding the final result date), will become ineligible for AACCC-PG counseling .
		R-1 admitted candidates who withdraw their seats with forfeiture from the date announcement of the 3rd Round final result will be ineligible for further Ayush-PG counseling. (Central/State/UT)
