**Kind Attention: All candidates participating in Stray vacancy Round of AACCC-UG Counseling for the A.Y. 2023-24.**

**Eligibility Criteria For candidates participating in the Stray Vacancy Round for AIQ seats under Govt./Govt. Aided / Central Universities/National Institutes**

1. Registered candidates who **have not been admitted to any seats** during any round of AACCC-UG counseling or State/ UTs Ayush UG Counseling 2023.
2. Candidates must submit a willingness in the AACCC-UG portal to participate in the Stray Vacancy Round with an undertaking that they are not holding any UG (ASU&H) seats allotted through AACCC-UG counseling or State/ UTs Ayush UG Counseling
3. Those candidates whose name is in the list of ineligible candidates published by AACCC, M/o Ayush vide notice dated 18.10.2023 **are not eligible** to participate in the Stray Vacancy Round of AACCC-UG Counseling 2023.

**NO FRESH REGISTRATION** and **NO UPGRADATION** during Stray Vacancy Round

**Admission Rules for the Stray Vacancy Round**

If Candidates get **allotted a seat in the Stray Vacancy Round**, they **must join the allotted institute**. If candidates **do not join the allotted seats**, their **security money will be forfeited**, and they will become ineligible for further AYUSH-UG counseling 2023. (Central/State/UT/Central Pool Quota).

**There is NO FREE EXIT** during the Stray vacancy Round

### Stray Vacancy Round for AIQ seats under Deemed Universities

As per the updated AACCC-UG counseling scheme, the seats that remain vacant after the Round-3 of AACCC-UG counseling will be reverted to the respective Deemed Universities to conduct Stray Vacancy Round at institute level. Therefore, candidates who registered in the AACCC-UG counseling and wish to take admission in the seats under Deemed Universities are advised to contact the respective Deemed Universities to participate in the Stray Vacancy Round conducted by the institute at their level. **(Schedule – 6<sup>th</sup> November to 18<sup>th</sup> November 2023)**

#### NOTE

- All candidates are advised to ensure that admission process made by the allotted college through online mode only by generating the **“Provisional Admission Letter”** from the AACCC UG portal. **Any admission made through offline mode shall be treated as null & void.**
- All participating institutes are instructed to facilitate the admission/reporting of students **even on holidays**, if necessary.
